

**Purpose** The Child Care Assistance Grant is a vital financial support program created to help families manage the costs associated with child care services. This grant is designed to ease the financial strain on parents and guardians, allowing them to access high-quality care for their children without worry. The \$5,000 grant empowers you to support parents in your program who receive child care assistance, helping them afford their copays and secure the best care for their little ones. Important deadlines and timelines are listed below.

- The grant period will be March 17, 2025- May 15, 2025
- A final impact report will be due May 30, 2025

## **Benefits of Partnership**

In addition to receiving funding, partners of Save the Children may also receive:

- 1. <u>Training opportunities</u> Save the Children has created an online training approved for CEUs in MS, TN, TX and WV. The Early Care and Education Empowerment Toolkit (ECEET) includes: early childhood pedagogy and environments, state-by-state resources (QRIS, licensing, CCRR, Child outcomes, performance standards, state-approved training, state-funded child care assistance, CACFP) Head Start resources, child care business resources, family child care business tools, prenatal resources, equity/inclusion resources, disability inclusion resources, behavior supports, professional organizations, empowerment toolkit (grant opportunities by state), and caregiver resources (by state)
- 2. <u>Technical assistance</u> staff at Save the Children are available to provide technical assistance to assist in the completion of this application.

#### **Grant requirements**

- 1. Facility/home address (if family child care home) must be within identified states and counties/parishes.
- 2. Tuition assistance has to be allocated to currently enrolled children who are receiving child care
- 3. Be a licensed program serving children in an early learning environment:
  - a. Early learning means any (a) State-licensed or State-regulated program or provider, regardless of setting or funding source, that provides early care and education for children from birth to



kindergarten entry, including, but not limited to, any program operated by a child care center or in a family child care home; (b) program funded by the Federal Government or State or LEAs (including any IDEA-funded program); (c) Early Head Start and Head Start program

- 4. A final written narrative report upon completion of the grant period that includes final programmatic deliverables and outcomes, a description of how funds were used, and final reporting on the number of child and adult beneficiaries served during the grant period.
- 5. Comply with the following SCUS policies:
  - a. Save the Children Behavior-Conduct-Guidelines
  - b. Zero-tolerance Fraud Policy
  - c. Conflict of Interest Policy
  - d. Code of Ethics and Business Conduct
  - e. Social Media Policy

## Please review Save the Children Behavior & Conduct Guidelines

SCUS prohibits all forms of Abuse, Exploitation, Human Trafficking, and Discrimination against child and adult program participants and community members, including, without limitation, the following:

Physical Abuse, Emotional Abuse, or Neglect of children



Engaging in any form of sexual activity with anyone under the age of 18 regardless of the age of consent locally. This includes grooming a child for sexual purposes. Ignorance or mistaken belief in the age of a child is not a defense.

Engaging in sexual activity with an adult program participant or the caretaker of a child program participant, except in the circumstance that such relationship predates one or both parties' involvement with SCUS.

Representatives are required to disclose any pre-existing relationships to their line manager.

Exchanging money, employment, goods, or services for any form of sexual activity, including sexual favors or other forms of humiliating, degrading, or exploitative behavior.

This includes exchanging assistance that is due to people participating in, or eligible for, SCUS Programs or buying or procuring sex acts from anyone at any time even when commercial sex transactions would be legal in the jurisdiction

Engaging or attempting to engage in any form of sexual abuse or sexual harassment toward any program participants and community members, including any child or adult.

The use of forced labor or engaging anyone under the age of 18 in any form of illegal or harmful child labor.

The recruitment, harboring, transportation, provision, or obtaining of a person for the purpose of any activity prohibited by this policy.

Destroying, concealing, confiscating, or otherwise denying access by an employee to the employee's identity or immigration documents or engaging in other activities that contribute to Human Trafficking

Discriminating against program participants or community members, including any child or adult, on any basis, including but not limited to race, ethnicity, religion, sex, sexual orientation, gender identity, disability, or any other basis prohibited by federal, state, or local law.

# Reporting safeguarding concerns, suspicions, and known incidents

All SCUS Representatives must report safeguarding concerns, suspicions, and known incidents - no matter how trivial the issue may seem - within 24 hours of becoming aware of the concern.


